I understand that THE AGILITY CHALLENGE is a private club, and that policies regarding use of the facility is set by the owners and operators, Daisy Peel, George Mariakis, and Courtney Farmer. As a member of THE AGILITY CHALLENGE club, it is my duty to share in the responsibility and workload of the club and contribute to its success. I understand and agree to facility policies and turf use rules and understand that my membership can be revoked at any time for violating

the policies, with no reimbursement of any membership fees paid. I also understand and agree that I will not use the facility for anything other than dog training, nor shall I accept payment of any kind for giving dog training lessons at The Agility Challenge Arena unless under a specific contract or rental agreement. I agree that I will not share my rental time or training privileges with anybody who is not also a member with training privileges.

I have read and understand the above. I agree to make every effort to meet the requirements within one (1) year from the date of this application. If I fail to complete the requirements within one (1) year, I acknowledge that I will be required to re-apply for Training Privileges after a six (6) month waiting period should I still wish to pursue club membership. GUIDELINES FOR MEMBERS' CONDUCT

The purpose of these guidelines is to promote cooperation among members, high standards of training, and sportsmanlike conduct at all times.

Handling methods should be based upon kindness and reward, exercising only sufficient firmness as each individual dog requires. Temper from any handler will never have a place while training at The Agility Challenge Arena. Self-defense or defense of your dog will be the only acceptable reason for severe handling. Good sportsmanship will be expected not only in the ring, but outside the ring as well. Members should present themselves in a manner which will have a positive effect on the reputation of The Agility Challenge Arena.

Members are expected to actively support the club's functions by serving as a volunteer, supporting needed fund-raising projects, attending club meetings and other special functions as announced. The amount of training or other participation one can give will naturally vary from member to member; it is expected that each will voluntarily contribute what they can. Cooperation is essential to the smooth functioning of the club; therefore, members should resolve any conflicts in a professional manner.

MEMBERSHIP AND POLICIES

1. Members with training privileges will abide by the training methods as approved by Daisy Peel.
2. Any dog trained must be owned or co-owned by the member, a member of his/hers immediate household, another member of The Agility Challenge in good standing, or a dog living in a member's household.
3. Members will receive a %10 discount towards the fee for any private lesson taken with Daisy Peel, as well as a %10 discount towards the fees for runs at any UKI Trial hosted by The Agility Challenge, or any seminars hosted by Daisy Peel and The Agility Challenge at The Agility Challenge Arena.
4. Once an application for Regular Membership is approved by Daisy Peel, the applicant will be eligible to take private lessons at the Member price.
5. Daisy Peel, George Mariakis, and Courtney Farmer have the authority to interpret and enforce the membership policy. He/she is the final authority on all matters on the training floor.
